Investment Strategy

A concentrated portfolio of companies we consider best placed to benefit from the stellar rise in the Indian economy.

Not only does India have the world's largest population, it also has its fastest growing economy. Having already overtaken the UK and Japan, India remains on track to surpass Germany and claim the number 3 spot by 2030. Its stock markets have been equally relentless, outperforming even the mighty US.

Despite these impressive developments, India remains a relatively closed, complex, and restrictive market for non-domestic investors. Vanquish India addresses these challenges by accessing Indian stocks via main market listed instruments, such as Global/American Depository Receipts and UK listed investment trust companies.

This approach secures access to the highest quality opportunities open to non-domestic investors today, whilst also establishing a forward-looking portfolio designed to evolve in step with India's development.








